1. In what direction should HCEA move in order to improve the overall educational climate in Harford County?

HCEA must do a better job of teaching the public about what teachers truly do. We need to make a deliberate effort to attend and partner with PTAs and describe our true activities and duties to parents.

Fact-filled presentations like the one Ryan gave to the Board of Education about salaries and comparisons to other Maryland jurisdictions need to be published and shared beyond the Board meetings.

In my work as GR Chair, I have heard elected officials say that if the public were demanding more education spending, officials would comply. So we need to move beyond COMplaining to EXplaining what we do. Not just that we are selflessly going "above and beyond" every day – though most of us are. But moreover that typical teachers simply and generously doing their duties are working very hard for increasingly small rewards.

I recall what one candidate at a GR forum last fall said to me. She asked, "have you heard about these things called SLO's? A teacher was telling me what they were and how they needed to do TWO of these this year at her school!" I of course explained that we ALL have to do two of those this year. I thought about how impossible it seemed that politicians seeking to work with us had no clue whatsoever what our challenges are.

So information and positive publicity needs to be shared broadly with the community.

2. What specific things would you do as an HCEA officer that would improve the Association?

As vice president I would coordinate efforts to issue reports and press releases about what teachers must do every day and every week.

I believe that this would help us also to address another critical issue: we need to increase our membership. Teachers have taken note of Ryan's excellent and tireless representation to the Board and Council of challenges and of educational decline in Harford County.

I would also collect simple examples of the hours we spend performing the required duties of our jobs. When our peers see us representing their lives accurately and continuing to fight for their compensation faithfully, perhaps new members will be moved to join.

Experience:

After earning my teaching certificate in both Biology and in French (I couldn't give one up so I got both) my first teaching job was in Baltimore City, at Hampstead Hill on Patterson Park. During my five years there teaching five classes a day of 40 students each, I earned my master's degree in Gifted and Talented Education at Johns Hopkins University. Also, I divorced my first husband and met my second. We married, I landed a job at Havre de Grace High School, and I thought my life might become less hectic.

But at Havre de Grace, my job as French Teacher has always kept me hopping. I have never had a year with fewer than four preparations, and most years it is five. I have taken on biology classes, English classes, and have acquired special training to provide SAT preparation. Because French has varied in popularity, I have become something of a marketing expert to keep my program alive. I am the sole sponsor the Student Government Association, and I lead the French Honor Society. For some years I ran a Future Teachers of America group, but few students show an interest in our profession any more. One year, we had a principal who decided that in addition to my four French preps, I should become the school's Test Coordinator. He took this duty off of guidance and assistant principals, and for two horrible years, he tasked me with administration all of the functional tests (these were test transition years), MSAs, HSAs PSATs and AP tests in addition to my four French preparations PLUS an English class that he tossed at me. I said to myself, "I will last longer than this guy," and I was right.

Also during the last 24 years, my husband and I have created a family. Our first daughter was born in July 1992, and our second child turned out to be triplets, born in January 1995. HCPS allowed 8 weeks off because they were a caesarian birth. And then, needing the salary and certainly needing the health insurance, back to the classroom went I. I have never stopped teaching since.

So if you wondered whether I as your Vice President can set goals, work hard, juggle career and family, or think creatively to solve problems, I hope you have a resounding answer to that question. You are darn right I can.

Grievance Process


5.5 Grievance Presentation. All grievances shall be presented in writing at Step 1 within ten (10) school days from the date of their occurrence, signed by the grievant. The Administrator's answer at each step shall be given in writing within ten (10) school days after the step meeting which shall be held within ten (10) school days following receipt of the appeal. Unless a grievance is appealed to the next step within five (5) school days after the Administrator's answer, it shall be deemed settled in accordance with the Administrator's answer, which shall be considered acceptable to the grievant and the Association.

If your contractual rights have been violated, you must inform HCEA within 10 school days of the violation so that the UniServ can file the grievance within the contractual timeline.

Your Unassigned Planning Time is Protected!

If your administrator requests attend meetings, have vou to a quick conversation, have a postobservation conference. evaluation conference, PPG meeting, etc. during your personal planning time, you need to assert your rights and inform your principal, "Article 8.7 (secondary schools) or 8.8 (elementary schools) of the negotiated agreement says that I am afforded unassigned planning time. While I am not opposed to meet with you, please schedule the meeting during my duty day, while honoring my planning and lunch times."

After asserting your rights, share the results with the HCEA office.
