We have crossed the half-way point of the 2016-17 school year and are rocketing to the finish thanks to a mild winter. The last pay date for this school year will be June 16th. The first pay for next year will not come until September 8th. This longer than usual gap is an unfortunate consequence of Governor Hogan's executive order mandating schools start after Labor Day. Since students start later, it pushes our start date into the next pay period. Please prepare financially for the extended gap in pay over the summer.

HCEA's Do Your Part campaign continues to build momentum. At the same time that Harford County Public Schools is experiencing a significant shortfall in state funding for education, Governor Hogan has proposed allocating \$10 million dollars to support private school vouchers. Governor Hogan has also proposed an independent charter school authorization and

governance authority. Were this legislation to be implemented, it would allow for-profit charter schools to operate independent of accountability and outside of our collective bargaining agreements, while stripping our public schools of much needed public funds. Know Your Contract

ARTICLE VI

<u>Transfers</u>

6.1 Voluntary Transfer. Requests for voluntary transfers will be accepted from tenured teachers who meet the certification requirements for the position identified. (A) The names of new schools to which teachers may request transfers for the following school year shall be announced. When the principal is appointed, that information will be distributed through the normal channels of communication and shared with the Association. (B) Requests for transfer to other than new schools are to be in writing and to be received prior to March 1 of the current year. A teacher may submit in writing a request to withdraw a request for a voluntary transfer prior to June 30. Principals must interview a minimum of three voluntary transfer candidates if three or more apply, before a new teacher candidate can be selected for a vacancy. The voluntary transfer candidate with the longest continuous service in Harford County must be one of the three candidates interviewed.

Unsuccessful candidates will be advised. The requests are to be in writing and to be received prior to March 1 of the current year.

Voluntary transfers will not be effected during a school year.

All such requests will apply to vacancies identified prior to July 15.

A part time teacher who has requested fulltime employment shall be considered for a position for which he/she is qualified before a new teacher may be hired for that position, except that voluntary transfers, leaves of absence and administrative transfers shall be given priority.
